

# Standardised Price List

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

## ATTENDED FUNERAL (funeral director's charges only) Total: £ 2700.00

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

Taking care of all necessary legal and administrative arrangements.	£ 300.00
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care.	£ 290.00
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at D & A Munn, Funeral Directors, 4 Breadalbane Street, Oban, Argyll, PA34 5NZ.	£ 640.00
Providing a suitable coffin – this will be made from an Oak veneer with pressed panels, a raised lid and appropriate furnishings.	£ 680.00
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer).	£ 0.00
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle.	£ 790.00

## UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

<sup>2</sup> In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

## TERMS OF BUSINESS

- The total price may change if you make additions or changes to the funeral service arrangements after we have provided an estimate of cost to you.
- We may ask you to pay a deposit to cover third party disbursements before the funeral. Payment should be made to D & A Munn Ltd 3 working days prior to the funeral to allow arrangements to proceed.
- The final funeral account will be sent to you following the funeral. The final balance will be due for payment 30 days after date of invoice, unless otherwise agreed by us in writing.
- If you fail to pay D & A Munn Ltd in full on the due date, we may charge interest on the balance due at a rate of 4% over Bank of England base rate. The interest will accrue on a daily basis from the due date until the date of actual payment. You must pay us interest together with any overdue amount. In exceptional circumstances we may employ the services of a debt recovery agency to secure payment on our behalf. You must pay us all reasonable costs, fees, disbursements and charges (including legal fees) incurred by us in recovering any unpaid invoices.
